#### ***Select an Attorney with a Track Record.***

Your automobile accident case is important to you because it affects you and your family. Your case is the opportunity for you to get fully compensated for the damages you deserve. It is important to choose an attorney that can deliver a full and fair verdict or settlement.

### **REASON #4**

Many automobile accident cases require serious investigation and are expensive to prepare. Not only will an attorney need to devote the time to your case but they need to have the resources to hire medical experts, economists or accident reconstruction experts, if necessary. Make sure the attorney will agree that you will not pay attorney's fees unless you win your case. It is important to choose an attorney who will believe in your case and agree to work for a contingency fee.
